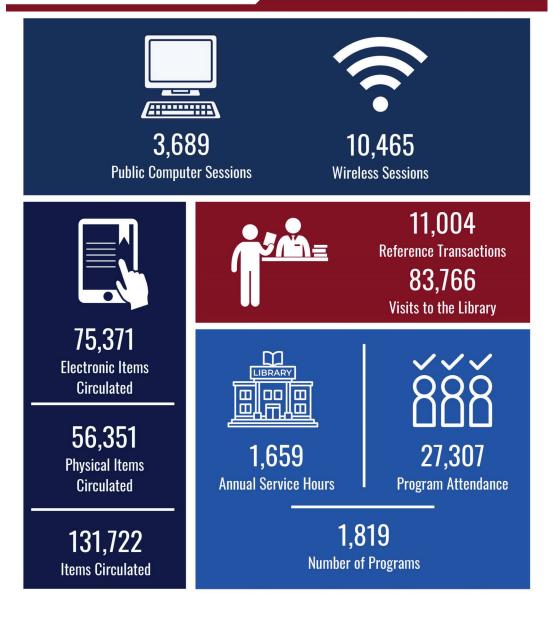

Please note the tax levy limit for the year 2025-26 from the Office of the State Comptroller is \$2,726,632 for the Westhampton Free Library. The proposed levy is \$2,726,245 for the 2025-26 year for the Westhampton Free Library. The proposed levy is below the tax cap levy limit by \$387. The levy limit is composed of the tax base growth factor of 1.0147 and the allowable levy growth factor of 1.0200 for a total allowable levy increase of \$93,384 to remain under the tax cap.*
